Documents must be no larger than 8.5" x 14" in at least ten (10) point type on 20 pound paper and not permanently bound or in continue form. The first and last pages of a document must contain 2" top and 2" bottom margins and 0.5" margin on each side. Any additional pages require at least a 0.5" margin on all four sides. Exempted documents are judgments, court order, writs, wills, death certificates, plat and surveys.
